DEAC conducted site inspection on 21/01/2017 and a meeting on 25/01/2017. The DEAC recommended for issuance of Environmental Clearance for the granite building stone quarry project of PPK Granites & Crusher Products Pvt. Ltd in Survey Nos. 135 of Ambalappara-II Village of Ottapalam Taluk in which a buffer distance of more than 100 mtr has been maintained.

The meeting of DEIAA chaired by the Chairman, DEIAA & District Collector was convened on 09/03/2017 to consider the proposals submitted by DEAC. After discussion of all the proposals with the Member Secretary, DEIAA and other members present. DEIAA decided to issue Environmental Clearance to the proponent subject to the general conditions enclosed with this order plus the specific conditions mentioned below:

1)A Mines manager shall be appointed to control, direct, manage and supervise the

Quarrying operations as required under the Mines Act, 1952.

- 2) Health and welfare measures for the persons employed shall be implemented.
- 3)Controlled blasting should be practiced and blasting shall be done only during day time. The mitigative measures for control of ground vibrations to arrest the fly rocks and boulders should be implemented.
- 4)Plantation shall be done which includes a green belt of adequate width around the Mining Lease area excluding the rocky area, along roads, overburden dumps and non mineralized area by planting suitable native specious in consultation with the local DFO/Agriculture Department.
- 5)The drains should be regularly de silted and maintained properly. Check dam and gully checks shall be constructed wherever required to arrest siltation. De siltation shall also be done every year before the onset of monsoon.
  - 6)Fencing must be maintained properly all around the lease area.
  - 7)The CSR need redrafting with inclusion of felt needs of the locality.
  - 8)Appropriate sign boards should be displayed.
  - 9)The blasting time must be displayed and strictly adhered to.
  - 10)The PPV values must be less than 10 mm/sec.
  - 11)Dust suppression mechanism must be in place.
  - 12)A separate small plot to be maintained in the premise to preserve rare and endemic species, if any, listed in the biodiversity assessment.

The proponent Sri. George Joseph, PPK Granites & Crusher Products Pvt. Ltd, Chunangad (PO), Ottapalam Taluk, Palakkad District has remitted the processing charge of Rs.1,00,000/-(Rupees One Lakh only) as per Chalan No. KL006684482201617 dt: 22/03/2017, District Treasury, Palakkad as one-time processing fee for Environmental Clearance in the name of O/o Member Secretary, DEIAA (Head of Accout - 1425-00-501-99). Also the total amount of CSR activities (of 5 years) is Eight lakh Ninteytwo thousand five hundred rupees which needs to be redrafted as per specific condition No. 7.

The clearance issued will also be subject to full and effective implementation of all the undertakings given in the application form, mitigation measures in the Environment Management Plan in Chapter 7 of the Pre-Feasibility Report and the mining features including progressive mine closure plan as submitted with the application and relied on for grant of this clearance. The above undertakings and the conditions and undertakings in mining, blasting, mine drainage, progressive mine closure plan of the Mining Plan as submitted will be deemed to be part of this proceedings as

conditions as undertaken by the proponent, as if incorporated herein.

Validity of the Environmental Clearance will be five years from the date of this clearance, subject to earlier review in the event of genuine complaint from anybody from the safety area or violation or non-compliance of any of the conditions stipulated herein. An affidavit submitted by proponent regarding compliance of the general and specific conditions has to be scrupulously followed.

Under the circumstances stated above, sanction is hereby accorded to Sri. George Joseph, PPK Granites & Crusher Products Pvt. Ltd, Chunangad (PO), Ottapalam Taluk, Palakkad District for the building stone quarry project of PPK Granites & Crusher Products Pvt. Ltd in Survey Nos. 135 of Ambalappara-II Village of Ottapalam Taluk. EC will become operational only after fulfillment of all the pre-mining conditions.

Compliance of the conditions herein will be monitored by the Geologist, Palakkad.

# GENERAL CONDITIONS (for mining projects)

- Rain Water Harvesting facility should be installed as per the prevailing provisions of KMBR / KPBR, unless otherwise specified.
- Environment Monitoring Cell as agreed under the affidavit filed by the proponent should be formed and made functional.
- Suitable avenue trees should be planted along either side of the tarred road and open parking areas, if any, including of approach road and internal roads.
- Maximum possible solar energy generation and utilization shall be ensured as an essential part of the project.
- Sprinklers shall be installed and used in the project site to contain dust emissions.
- 6. Eco-restoration including the mine closure plan shall be done at the own cost of the project proponent.
- 7. At least 10 percent out of the total excavated pit area should be retained as water storage areas and the remaining area should be reclaimed with stacked dumping and overburden and planted with indigenous plant species that are eco-friendly, if no other specific condition on reclamation of pit is stipulated in the E.C.

- 9. The lease area shall be fenced off with barbed wires to a minimum height of 4ft around, before starting of mining. All the boundary indicators (boards, stores, markings, etc) shall be protected at all times and shall be conspicuous.
- 10. Warning alarms indicating the time of blasting (to be done at specific timings) has to be arranged as per stipulations of Explosive Department.
- Control measures on noise and vibration prescribed by KSPCB should be implemented.
- 12. Quarrying activities should be limited to day time as per KSPCB guidelines/specific conditions.
- Blasting should be done in a controlled manner as specified by the regulations of Explosives Department or any other concerned agency.

In the case of any change(s) in the scope of the project, extent quantity, process of mining technology involved or in any way affecting the environmental parameters/impacts as assessed, 32. based on which only the E.C is issued, the project would require a fresh appraisal by this Authority, for which the proponent shall apply and get the approval of this Authority.

The Authority reserves the right to add additional safeguard measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the 33. provisions of the Environment (Protection) Act, 1986, to ensure effective implementation of the

suggested safeguard measures in a time bound and satisfactory manner.

The Project proponent shall ensure that no natural water course and/or water resources shall be obstructed due to any mining operations. Necessary safeguard measures to protect the first order

estreams, if any, originating from the mine lease shall be taken.

Monitoring of Ambient Air Quality to be carried out based on the Notification 2009, as amended from time to time by the Central Pollution Control Board. Water sprinkling should be increased at 42. places loading and unloading points & transfer point to reduce fugitive emissions.

The top soil, if any, shall temporarily be stored at earmarked site(s) only for the topsoil shall be used for land reclamation and plantation. The over burden (OB) generated during the mining 43. operations shall be stacked at earmarked dump site(s) only. The maximum height of the dumps shall not exceed 8m and width 20m and overall slope of the dumps shall be maintained to 450. The OB dumps should be scientifically vegetated with suitable native species to prevent erosion and surface run off. In critical areas, use of gco textiles shall be undertaken for stabilization of the dump. The entire excavated area shall be backfilled. Monitoring and management of rehabilitated areas should continue until the vegetation becomes self-sustaining.

Catch drains and siltation ponds of appropriate size shall be constructed around the mine 44.

working, mineral and OB dumps to prevent run off of water and flow of sediments directly into the river and other water bodies. The water so collected should be utilized for watering the mine area, roads, green belt development etc. The drains shall be regularly desilted particularly after monsoon and maintained properly.

45. Effective safeguard measures such as regular water sprinkling shall be carried out in critical areas prone to air pollution and having high levels of PM10 and PM2.5 such as haul Road, loading and unloading points and transfer points - it shall be ensured that the Ambient Air Quality parameters conform to the norms prescribed by the Central Pollution Control Board in this regard.

46. Fugitive dust emissions from all the sources should be controlled regularly. Water spraying arrangement on haul roads, loading and unloading and at transfer points should be provided and

properly maintained.

47. Measures should be taken for control of noise levels below 85 dBA in the work environment.

A separate environmental management cell with suitable qualified personnel should be set-up 48. under the control of a Senior Executive, who will report directly to the Head of the Organization.

The funds earmarked for environmental protection measures and CSR activate should be kept in 49. separate account and should not be diverted for other purpose. Year wise expenditure should be reported to the State Environment Impact Assessment Authority (SEIAA) office.

The Regional Office of MOEF & CC located at Bangalore shall monitor compliance of the 50. stipulated conditions. The project authorities should extend full cooperation to the officer (S) of

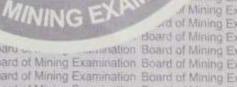

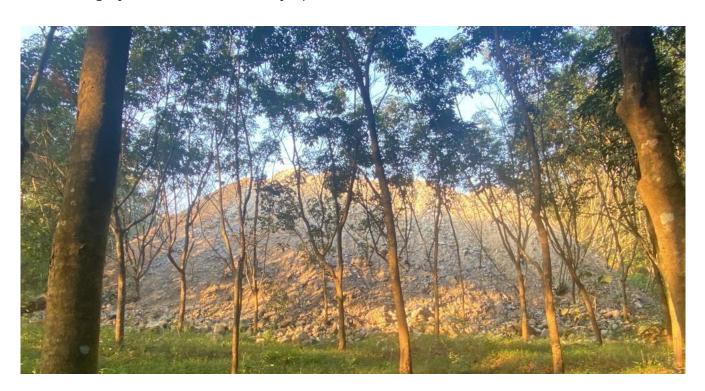
